#### Revisions to the Emergency Solicitation for the DHS City Sanctuary Intake Facility

Please be advised that the subject emergency solicitation is described below. All new language is **bolded and underlined**. Language that is crossed out is being deleted from the emergency solicitation.

#### Page 1, paragraph 2, is revised as follows:

DHS has identified a location for the Facility in midtown Manhattan. Vendors can propose an alternative site, but that site would also need to be located in midtown Manhattan. The current site, and any alternative site offered, will include space for intake and housing for 600 households. The selected vendor will perform all services for the Facility as outlined in this solicitation. These include intake actions, client assessment and ongoing services provision for all clients staying in the Facility. The population served by the selected vendor will be families with children, adult couples, and individual adults. This solicitation is the Facility only, with proposals due on August 10<sup>th</sup> by 2:00pm on Thursday, August 18, 2022. Proposers are advised to ready, willing, and able to provide services on 24 hours' notice.

#### Page 2, paragraph 1, is revised as follows:

The selected vendor is expected to initiate the provision of services on or about August 15, 2022 August 25, 2022; however, the proposer should demonstrate how it can open the Facility with 24 hours' notice.

#### Page 4, F. Proposal Instructions and Basis of Award, paragraph 1, is revised as follows:

Interested entities should complete the attached application form and indicate the number of rooms, or the site(s) if applicable, for which it would like to propose services

#### Page 5, F. Proposal Instructions and Basis of Award, paragraph 4, is revised as follows:

If you are interested in applying to provide the above services, please submit your proposal to <u>ACCOContractPlanning@dss.nyc.gov</u> by <u>August 10, 2022</u> <u>2:00pm on Thursday, August 18,</u> <u>2022.</u> Note that the City will open proposals and score proposals once received and commence services upon DHS' notice to proceed.

#### Attachment B: Questions and Answers from the Information Session

Please Note: No further questions regarding this solicitation will be considered.

## 1. Question: Do [organizations] have to have 501c3 status to apply and can groups of [organizations] submit a joint proposal (pooling resources and strengths to have a robust service center)?

**Answer:** For the DHS Intake Facility solicitation, organizations will need an IRS 501(c)(3) determination letter in order to propose on the services. For the DHS City Sanctuary Facilities solicitation, proposers will need to have an IRS 501(c)(3) determination letter to propose on the services to be provided on-site, however If you are a building owner proposing in the operating portion of the contract, you do not need to have a IRS 501(c)(3) determination letter.

#### 2. Question: Can multiple [organizations] apply together?

**Answer:** Yes, multiple organizations can apply together. For the City Sanctuary Intake Facility, there should be a lead proposer and subcontractors can be proposed as part of the proposal team. Please be sure to clearly list each team member's specific role. It's very important that the group members have the organizational capability for this program. Please include an organizational chart that shows how the team (or consortium) would work.

For City Sanctuary Facilities, DHS also anticipate some type of teaming. A membership organization, a consortium of vendors/operators that work together, or an ownership group can propose together in the manner described above.

3. Question: We have a network of thousands of CBO partners in NYC for referrals. Are we able to apply for the portion of the RFP focused on connecting to services that [are not] onsite and the data/tracking, or would we need to partner directly with a lead non-profit?

Answer: Please see question 2.

4. Question: Can you confirm that a "unit" is a room and that a family or couple or adult will each be housed in a unit or room.

Answer: Yes, a unit is a room

## 5. Question: Do the 150 units need to be located in one location or can you have 100 beds at one site and 50 beds at another location?

**Answer:** We strongly recommend that proposals that have minimum of 150 units and strongly encourage proposers to spend the time finding a building that has at least 150 units.

### 6. Question: Where can we find the solicitation for the Next Step facilities. I only received notification for the Intake facility procurement.

## 7. Question: Does the Sanctuary Intake Center have cook on site facilities or will it require Cold & Hold meals to be brought in?

**Answer:** The intake center will not have a cooking facility, and DHS expects that the proposals will include food. For the other facilities, proposals should include a food within their proposals.

#### 8. Question: How soon is the expectation for the first sites to open?

**Answer:** If selected, vendors should be expected to respond within 24-hours' notice to be operational at their proposed site(s). We anticipate few of sites opening this month once proposals come in.

## 9. Question: Would [there] be a closet or vouchers for them to receive clothing?

**Answer**: There should be laundry services included in your proposal. Non-forprofits who will be supplying clothing vouchers and/or payment for clothing should include the needed amounts within the proposed budget. Proposers should think along case management linkages and referrals to various organization across New York City that also provide clothing or a combination of both.

## 10. Question: What is the possibility of extending the contract after the first year?

**Answer:** How far the contracts will extend or whether they would be extended is unclear at this point.

#### 11. Question: Will these contracts be through HRA or DHS?

**Answer:** These contracts will be managed through DHS.

#### 12. Question: Should the meals all meet NYC food standards?

Answer: Yes, all meals must meet NYC Food standards.

#### 13. Question: Will refrigerated and heating equipment be needed?

**Answer:** Yes, proposers should provide microwaves for heating meals and refrigerators for meals that are not immediately distributed. All food must be consistent with NYC food standards.

## 14. Question: Is there a possible way to get an updated sheet on the organization that would help with donations i.e. Clothing. Since a lot of organizations serve specific people

**Answer:** Please see Attachment E in this addendum. A list has been provided.

### 15. Question: Is there a space where vendors of a specific service can list their services for other entities that are in need that service? i.e. like food?

**Answer**: If you have access to services such as food, we ask that you include the information in your proposal submission.

#### 16. Question: Where will DHS open these sites?

**Answer:** The intake facility site will be located in midtown Manhattan. For the City Sanctuary Facilities, the proposer will propose a site for approval. Please note, the appropriateness of proposed location is subject to DHS review and approval.

## 17. Question: With Sanctuary, would [a proposer need to] provide help with jobs?

**Answer:** Similar to permanent housing, assistance and eligibility will depend on the individual asylum case.

18. Question: Apologies if this is in the RFP, but what does HRA anticipate will be timeline for individuals and families at Next Step Sanctuary facilities to get permanent housing, and is that dependent on receipt of a decision on their asylum case? What is expected of vendor re: securing permanent housing?

**Answer:** It is a process contingent upon individual asylum cases and how long clients will need the support of these facilities.

19. Question: Immediate needs question: Where can we send people right now who are in need of food and clothes while waiting for services to start? (For orgs who are limited on resources). For instance, provide services everyone who comes through the door, however the way work is structured we were not supposed to be giving direct services. Who can they redirect family to?

**Answer:** DHS provide food, bed, care kit if they are in shelter. Food banks provide food to local communities; a list of food banks is located on the HRA website.

## 20. Question: Would there be set aside immigration workers and HRA staff/centers to assist facilities with the clients immediate needs.

Answer: Proposers should include linkages for those type of services.

## 21. Question: Will a "City Sanctuary Facility" be given SPS targets or included in the provider's SPS numbers?

**Answer:** SPS indicators do not necessarily apply here. This program is separate from DHS shelter system. It is tracked differently and has different requirements.

22. Question: We are nonprofit organization that have been receiving asylumseekers at Port Authority and we do intake, ensure they are well, get them medical attention if needed, feed them, and get them sorted out to other destinations and/or direct them to shelters (and with assistance from other volunteers, escort them and ensure their intake).We would be one piece of the intake process. We would then hand off asylum-seekers to another group whose expertise and advocacy can provide assistant to being successfully placed in shelters/ or the new housing you are proposing in solicitation #2. Is the contract for intake going to one place and we be a link to them, or do we have to submit an application separately and directly?

**Answer:** The RFP is for a provider to operate both the intake and the housing of the clients who come through the intake center. Vendors can partner with each other to provide varying parts of the service but there needs to be one lead organization with clear subcontract agreements and responsibilities.

# Asylum Seekers: What do we know?

- More than 4,000 people entered DHS shelter so far.
  - ~100 people each day.
- More than 60% of people are in FWC.
- Households have very limited resources.
- Coming from primarily a range of Central/South American countries.
- Many pathways to NYC:
  - TX and AZ governors to Washington DC, DC nonprofits busing to NYC
  - TX and AZ nonprofits paying for bus tickets.
  - TX starting to send buses to NYC
  - Client choice

## **Federal Process**

- The federal government begins processing individuals/households at the border and initiates the deportation proceedings process if those individuals/households do not have entry documentation.
  - Some are paroled (granted temporary entry) into the United States, others are not. These determinations are made at the discretion of the border agent.
- Clients typically have appointments to appear at 26 Federal Plaza.
  - MOIA standing up services, including legal support
- Households may be eligible for some benefits after submitting applications for asylum and throughout the asylum process – specific to individual circumstances.
- NYC in discussion with the federal government to improve information flow, resources.

## **Additional Information**

The NYC Department of Social Services in partnership with NYC Mayor's Office of Immigrant Affairs and its partners in the humanitarian sector will be available to support selected shelter providers with technical and capacity building assistance in serving the unique needs of the asylum seeking population. We refer you to the UNHCR <u>Border Shelter Toolkit</u> and <u>Resource Library</u> for initial guidance. While the recommendations and resources contained therein relate to short-term emergency shelter operations at the U.S. Southern Border, the information may provide a useful introduction to the unique needs and realities of asylum seekers, and best practices for optimal shelter design and service provision.
